07/08/19 Spud 17 1/2" hole. TD 17 1/2" hole @ 1850'. Ran 395' of 13 3/8" 54.5# J55 ST&C Csg. Cemented with 275 sks Class C w/additives. Mixed @ 12.0#/g w/2.51 yd. Displaced w/52 bbls of BW. Plug down @ 4:15 AM 07/09/19. Circ 115 sks of cmt to the pit. Test BOPE to 5000# & Annular to 3500#. At 6:00 A.M. 07/11/19, tested csg to 1500#, held OK. FIT test to 10.5 PPG EMW. Drilled out with 12 1/4" bit.

07/12/19 TD 12 1/4" hole @ 1770'. Ran 1755' of 9 5/8" 40# N80 LT&C Csg. Cement 1st stage with 225 sks Class C w/additives. Mixed @ 11.5#/g w/2.63 yd. Tail w/200 sks Class C w/1.0% CaCl2. Mixed @ 14.8#/g w/1.33 yd. Displaced w/129 bbls of FW. Plug down @ 12:00 AM 07/13/19. Circ 41 sks of cmt to the pit. Set Universal mandrel hanger through BOP w/80k#. At 9:30 P.M. 07/13/19, tested csg to 1500#, held OK. FIT test to 10.5 PPG EMW. Drilled out with 8 3/4" bit.
