06/25/2019: Finish tally in with tubing and tag CIBP at 9680'. Circulate hole with 9.5# plug mud.

06/25/2019: Plug 1: Spot 25 sx "H" from 9680-9480. WOC and tag at 9465'.

06/26/2019: Plug 2: Spot 25 sx "H" from 8800-8600. WOC and tag at 8612'.

06/27/2019: Plug 3: Spot 25 sx "C" from 7012-6762. WOC and tag at 6760'. Plug 4: Spot 25 sx "C" from 5880-5630. WOC and tag at 5625'.

06/28/2019: Plug 5: Unable to establish injection to squeeze. BLM approved balanced plug. Spot 25 sx "C" at 5200-4950. WOC & tag at 5005'.

07/01/2019: Plug 6: Perf & squeeze 30 sx "C" from 2550-2450. WOC and tag at 2441'.

07/02/2019: Plug 7: Perf & squeeze 25 sx "C" from 950-800. WOC and tag at 745'. Plug 8: Perf and squeeze 85 sx "C" from 350' to surface.

07/09/2019: Cut off wellhead and found top plug 8' below surface. Filled to surface with 5 sx "C". RD cementers and install dry hole marker.
