Cmted lead w/300 sx (561 cf) 35/65 PLite/C w/5% (PF44) salt, 6% (PF20) gel, 0.2% (PF17) fluid loss, 0.2% (PF13) retarder, 0.1% (PF153) anti settling, 3#/sx (PF42) kol-seal, 0.4#/sx (PF45) defoamer, & 0.125#/sx (PF29) cellophane. Tailed w/700 sx (931 cf) "C" cmt w/0.2% (PF65) dispersant, 0.2% (PF606) fluid loss, & 0.125#/sx (PF29) cellophane. Circ 105 sx cmt to surface. Released rig on 7/16/19. Plan to pressure test 5-1/2" csg during completion operations.
