BOP break test under the following conditions:

- After a full BOP test is conducted
- When skidding to drill the production section where the surface casing is set into the third Bone Spring or shallower.
- When skidding to drill a production section that does not penetrate into the third Bone Spring or deeper.

If the kill line is broken prior to skid, two tests will be performed.

- 1) The void between the wellhead and the pipe rams
- 2) The kill lines and the choke manifold

If the kill line is not broken prior to skid, only one test will be performed.

- 1) The void between the wellhead and the pipe rams
