12/27/19 Casing and tubing on a slight vacuum. Circ to kill well with 117bbls FW. Function tested BOP. Pumped 6bbls brine down casing, 3bbls brine down tubing.
12/28/19 POOH with 2-3/8" tubing. Pumped 18bbls FW down casing, pressured up to 500 psi, held.
12/30/19 RIH with CCL and 3.75" gauge ring, tagged CIBP at 12000'. Circ 170bbls gel brine.
