04/29/06 Ran 13-3/8" 48# H-40 STC casing to 510'. Cemented lead with 320 sx Premium Plus (wt 13.7, yld 1.68) + 4% Bentonite + 2% Calcium Chloride + 0.25# Flocele. Cemented tail with 150 sx Premium Plus (wt 14.8, yld 1.35) + 2% Calcium Chloride. Circulated 23 sx to surface. WOC 19.5 hours. Pressure tested casing to 1000 psi for 30 minutes.

05/07/06 Ran 9-5/8" 40# J-55 LTC casing to 4030'. Cemented lead with 1000 sx Interfill C (wt 11.9, wt 2.45) + 0.25# Flocele and tail with 200 sx Premium Plus (wt 14.9, yld 1.34) + 1% CaCl. Circulated 66 sx to surface. WOC 19 hours. Pressure tested casing to 1000 psi for 30 minutes.
