Cemented with 165 sks Class C w/2% CaCl2. Mixed at 14.8 #/g w/ 1.34 yd. Circulate 25 sks to pit. Drilled out with 17 1/2" bit.

Tail with 400 sks Class C with 2% CaCl2. Mixed @ 14.8 #/g w/ 1.34 yd. Circ 98 sks to pit. WOC 18 hrs. At 7:45 am 04/16/06, test 13 3/8" casing to 1500# for 30 minutes, held OK. Drilled out with 12-1/4" bit.
