Devon Energy Production Company, LP is applying with the NM OCD for approval to downhole commingle the Red Lake Queen-Grayburg-San Andres (51300) and the Northeast Red Lake Glorieta Yeso (96836) pursuant to 19.15.5.303 (C) 3 (b) Exceptions for wells located in pre-approved pools or areas. This pool was pre-approved by NM OCD Division order PC-1108.

The San Andres is perforated at 2952-3280' and the Yeso is perforated from 1937-2376'. Average production from the SA is 8.658 oil and 3.58 gas. Average production from the Yeso is 17.34 oil and 21.43 gas.

The allocation method is by ratio of stabilized production. For the Yeso, oil is 66.7% and gas is 85.7%. For the San Andres formation, oil is 33.3% and gas is 14.3%.

Commingle these two pools will not reduce the value of the total remaining production and the ownership between the two pools is identical.
