7/29/06 Plug had moved down 31'. TIH to set new composite bridge plug at 12,400'. Perforate Morrow 11,980'-11,988' (48), 11,914'-11,920' (36), 11,890'-11,896' (36) and 11,880'-11,888'.

7/31/06 Set RBP at 12,050'. Acidize Morrow 11,880'-11,920' with 1000g 7-1/2% Morrow acid. 2-7/8" tubing and packer at 11,820'.
