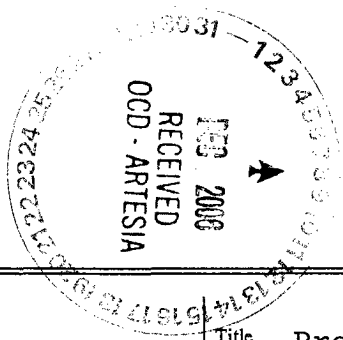

Drill 12 1/4" hole to 1947'. Run 9 5/8", 36#, J-55 casing to 1947'. Cement w/total of 2100 sx thixotropic and Class C cement and additives. Circulate 15 sx to surface. Circulation achieved via 1" tubing over 52 hr. period spotting multiple plugs w/WOC between each. NU & test BOP and casing to 1500 psig. Resume drilling w/8 3/4" bit.
