Spud well @ 0930 Hrs on 12/9/200-6 with 17-1/2" hole and drill to 300'. Run 8 jts. of 13-3/8" N-80 68 #/FT BT&C. Set 13-3/8" casing @ 300'. Cement with 150 SXS RFC (10-2-A) + 5 PPS D24 1/8 PPS D130 and tail w/ 355 SXS C + 2% S1 + 1/8 PPS D130 + 5 PPS D24. Plug down @ 10:00 pm 12/9/06. Circ. 150 SXS to pit. WOC 8 Hrs. Cut off 13-3/8" csg., weld on wellhead. Test to 3000 PSI. Held OK. Nipple up BOP and test to 600 PSI. Held OK. WOC total of 24 Hrs. Trip in hole with 12-1/4" bit and drill cement and float collar. Test pipe rams & casing to 600 PSI. Drill out casing shoe and resume drilling formation w/ 12-1/4" bit.
