13. Describe Proposed or Completed Operation (clearly state all pertinent details, including estimated starting date of any proposed work and approximate duration thereof. 1. The oil wells on the Duncan Federal lease, intermittently produce a small amount of casing head gas. This gas is sour and is unmarketable for the following reasons:

- The gas cannot be put in a standard natural gas pipeline because it is sour.
- The produced volumes of gas are too small to justify construction of a plant to eliminate the H₂S.
- There is no sour gas pipeline in the area.

2. Currently the wells each have a propane tank on location. A well is started on propane but sometimes can be switched to run off the well head gas if sufficient gas is available after most or all of the fluid is evacuated from the well.

3. We propose to run a plastic 1 1/4" to 2" pipeline to each well on the Duncan lease as shown on the attached schematic. By doing this we hopefully can eliminate the need for most propane tanks as gas from producing wells is used to run engines on wells which are loaded with fluid or which produce insufficient gas to pump the well. The pipeline would run beneath the existing road right-of-way, all of which previously has had archeological surveys. The line will be buried 3 feet deep but we request authority to test the pipeline on the surface before it is buried.

4. The above plan may necessitate the installation of one or more gas separators. We are presently consulting with experts on this matter to make this determination.
