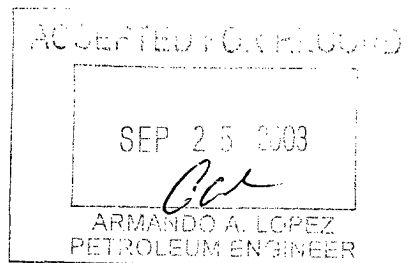

Perforate Abo 3734'-3748' (15), 3754'-3756' (3), 3824'-3832' (9), 3866'-3878' (13), 3886'-3894' (9), 3898'-3908' (11), 3982'-3988' (7) for a total of 67 holes. Stimulate as needed. Will possibly commingle the Wolfcamp and Abo.
