3. Cut off 4 1/2" casing @ 925' & POOH.
4. Set 100 sx cmt plug from ~~925'~~<sup>825'</sup> - 825' & tag.
5. Perf 8 5/8" casing @ 200'. Set packer @ 190'.
6. Pump 125 sx cmt down tubing & circ outside of 8 5/8" casing to surface.
7. Set 20 sx cmt plug @ surface.
