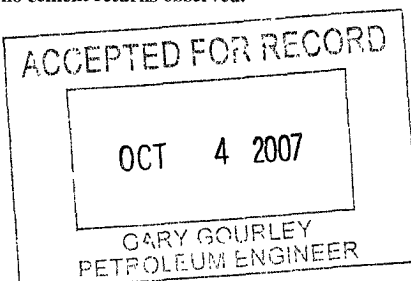

RU TIW swivel, wash to bottom, set liner 2' off bottom. Release from liner. Cement w/ 600 sx class H cmt. + 4% BA + 0.3% CD32 + 1% FL-62 + 4% R3. Set packer w/100K shear. Pull 10 stands, circulate 1.5 times bottoms up - no cement returns observed.
