Yates Petroleum Corportation respectfully requests permission to eliminate the BOP test within 500' of Wolfcamp formation. The BOP will be tested after setting the intermediate casing at approximately 1550'. The Wolfcamp will then be drilled before the allotted 20 days as per my conversation with Wesley Ingram, BLM Carlsbad.

If the time between setting the intermediate casing and reaching the Wolfcamp exceeds 20 days, another BOP test will be needed.
