Based on subsurface evaluation and recent swab data, BP would like to return this well to production by equipping to rod pump and laying a new flow line. BP would like to request an extension of 60 days to obtain partner approval for returning the well to production. This well is expected to be fully returned to production by May 24th, 2008.
