ON MARCH 15, 2008, 40' OF 14" CONDUCTOR PIPE WAS MISTAKENLY SET AND CEMENTED IN PLACE. THE CONDUCTOR PIPE SHOULD HAVE BEEN 20" DIAMETER. THE 14" CONDUCTOR PIPE WAS CUT OFF 6' BELOW GROUND LEVEL AND THE REMAINING PIPE WAS FILLED WITH CALICHE. MOVED CELLAR TO THE WEST AND DRILLED CONDUCTOR HOLE 5' WEST OF THE ORIGINAL WELL STAKE. 40' OF 20" CONDUCTOR PIPE WAS SET AND CEMENTED IN PLACE. DUE TO THIS ACTION, THE WELL LOCATION WILL NOW BE : 950' FSL, 995' FEL.
