Devon Energy Production Company, L.P. requests approval to re-complete to the Wolfcamp zone as follows:

1. MIRU workover rig. ND wellhead and NU BOP. Drill out CIBP @ 3515'.
2. MIRU WL unit and perforate for cement squeeze at 6300' with cement retainer at 6250'. Perform cement squeeze from 6300' up to calculated TOC of 5600'.
3. RIH and perforate the Wolfcamp formation from 6076' to 6082', 2 spf, 0.40 EHD holes. Pick up and set packer at +/- 5970'. Acidize Wolfcamp at 6076'-6082' down tubing with 3000 gallons 15% HCl.
4. Release packer. Swab test Wolfcamp.
