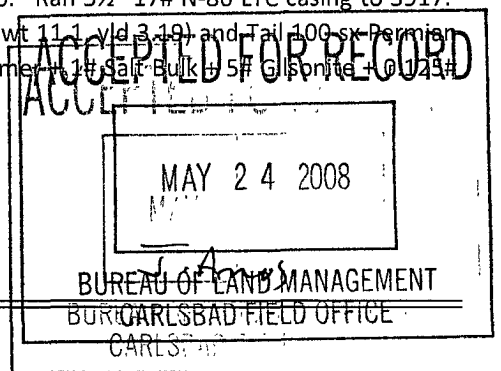

Cemented with Lead 300 sx Interfill C + 0.125# Poly-e-flake + 0.4% Econolite (wt 11.1, yld 3.19) and Tail 100 sx Permian Basin Super H + 0.5% Halad-344 + 0.25# D-AIR 3000 + 0.4% CFR-3 w/o Defoamer + 1# Salt Bulk + 5# Glsomite + 0.125# Poly-e-flake + 0.25% HR-7 (wt 13.2, yld 1.61). Circulated 35 sx to surface.

12.30.07 Released rig.

01.20.08 Pressure-tested production casing to 3000 psi for 30 minutes.
