Cemcrete Lead with additives (yield = 2.47; density = 10.2 ppg and 200 sk. PVL Tail with additives (yield = 1.4; density = 13.0 ppg.). Opened DV tool and circulated. Cemented 2nd stage with 290 sx. Poz/C Lead with additives (yield = 1.98; density = 12.6 ppg.). Bumped plug. Float held. Nipped down BOP.

Rigged down and released rig at 02:30 hrs. on 5/13/2008.
