5-13-08: Perf from 5624, 37, 50, 55, 67, 5722, 26, 36, 38, 46, 52, 82, 90, 98, 5803, 06'. TIH w/packer to 5863' & test plug to 1500 psi. Moved packer to 5481' and set. Loaded backside. Pumped 2500 gals 7 1/2% acid. RU swab.

5-14-08: Fraced well w/51000 gals gel and 44825# 30/50 sand + 15000# 20/40 sand.

5-15-08: Unset packer, latched onto plug & TOH. TIH w/notched collar & washed to 6181'. Circulated hole. Ran in hole w/2 7/8" tubing (185 jts) & SN. Ran pump & rods.
