5/31/2008: MIRU Cudd Pumping Service. Frac new Delaware perfs w/ 37316 gals BFRAC 30, 102820#'s 16/30 Ottawa Sand and

40253 #'S 16/30 Super LC. RD Cudd.

06/03/2008: MIRU Chance Foam Air Unit. RIH w/ 4-3/4" blade bit, break circ w/ Foam Air &amp; wash down to CIBP. POOH w/bit. 06/05/2008 PU &amp; RIH w/ 189 jts 2-7/8" tbg. &amp; set SN @ 5938' &amp; TAC @ 5807'.

06/06/2008: RIH w pump &amp; rods. RDMOPU &amp; return well to production.

06/20/2008: Well test pumping 85 BO, 180 BW, 65 MCFG, TP 200, CP-500 PSI.

Please be aware that it is BEPCO's intention to produce the new Delaware perfs for approximately 3 months then drill out the CIBP @ 6250' and produce all perfs. The lower perfs from 7256-7266' are only temporarily zone abandoned.
