Circulated with 90 sks 35/65 Poz C + 6% D20+0.125PPSD130+0.2%D46, Tail with 50 SKS C Neat. Drill out to 3660' and test. Ran temperature survey log. Log indicated TOC @ 3189'. Cement top approved verbally by J.Amos @ 3200'. Installed pumping equipment and placed well on production.
