6-13-08: Reached 2465'. Circulate hole. Ran 9 5/8", 36#, K-55, STC casing to 2465'. Halliburton cemented with lead 700 sx EconoCem + HCL 5% salt 12.4 weight, 2.12 yield; tail with 200 sx SwiftCem + 1% CaCl2 14.8 weight, 1.34 yield. Plug down. Circulated 140 sx to surface BLM witnessed. WOC 18 hrs. Tested to 1600 psi for 30 minutes. Test BOP 300 low 5000 high.

7-6-08: Reached 9750', ran 7", 26#, P-110, LTC casig to 9750'. Halliburton cemented with lead 1000 sx VersaCem H + 8% bentonite + 3% Halad 9 + 5% salt + 1/2 # sx PloyE Flake. Tailed with 200 sx Prem H + .5% Halad 9. Plug down. Cement did not circulate. WOC 18 hrs. Ran temp survey - top of cement @ 600'. Picked up 1" pipe and tagged cement @ 600', cemented with Halliburton cement - 62 sx Cl C + 2% CaCl2 weight 14.8, 1.35 yield. Circulated 8 sx to pit. WOC. Pressure tested to 3000 psi for 30 minutes. Tested BOP to 10000 psi.
