Cemented with 150 sx RFC + 9.4#/sx D53 + 0.125#/sx D130 + 3#/sx D42 + 94#/sx D903 + 1.88#/sx S1 (yld 1.62, wt 14.2) and 290 sx Class "C" + 5.64#/sx D20 + 3.18#/sx D44 + 0.188#/sx D46 + 94#/sx D903 + 1.88#/sx S1 (yld 2.26, wt 12.5). Tailed in with 200 sx Class "C" + 94#/sx D903 + 1.88#/sx S1 (yld 1.33, wt 14.8). Cement did not circulate. Ran 1" cement to surface with 625 sx Class "C" cement with additives. Tested casing to 600 psi for 30 min. WOC 79 hrs 50 min. Reduced hole to 7-7/8" and resumed drilling.
