01/09/09 Frac perfs w/2000 gals acid, 53500 gals 20# SW w/25,000# 20/40 sand.

01/10/09 RIH w/tbg to 2789'. Tag fill @ 2854'. CIBP @ 2860. Run tbg, pump & rods. Hang well on. Producing all Yeso perfs.

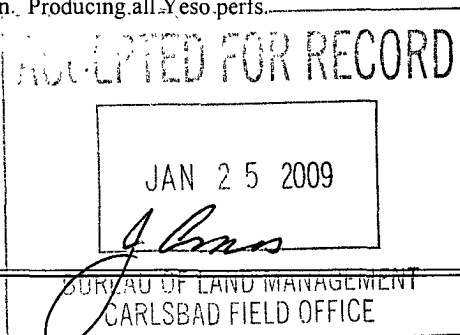
