TD for this well is going to be approx. 11,822'. This is 200' of new hole from the original well TD(11,622') and about 1300' shallower than the permitted TD of 13,125'. With that, it's believed that 4 1/2" 11.6# HCP-110 would be sufficient rather than using the 13.5# P-110 as originally permitted.
