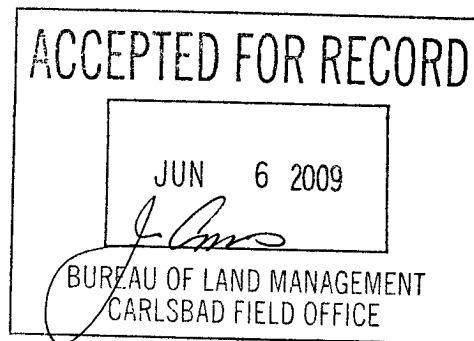
Ran 15 jts 8-5/8", 32 #, J-55 STC casing set at 624'.

5/27/09 Tested casing to 1500 psi for 30 minutes. Test good.
