Forest Oil is requesting TA status on the above mentioned well. The Skelly Unit #203 is to be utilized for future beneficial purposes. A field study is in progress which will determine the purpose of the wellbore. Current options include conversion to injection to support offset producing wells or conversion to a producing well. The zones targeted for the recompleat are the Grayburg and Seven Rivers. It is anticipated that the product pricing will allow for an economic conversion or recompleat. The anticipated date for this work is unknown at this time, but the study will continue into the year 2010. Richard Inge witnessed and retained the charts of an MIT test that was run on 8-21-2009, pressured up to 500 lbs., held for 30 minutes, CIBP @ 3095'.
