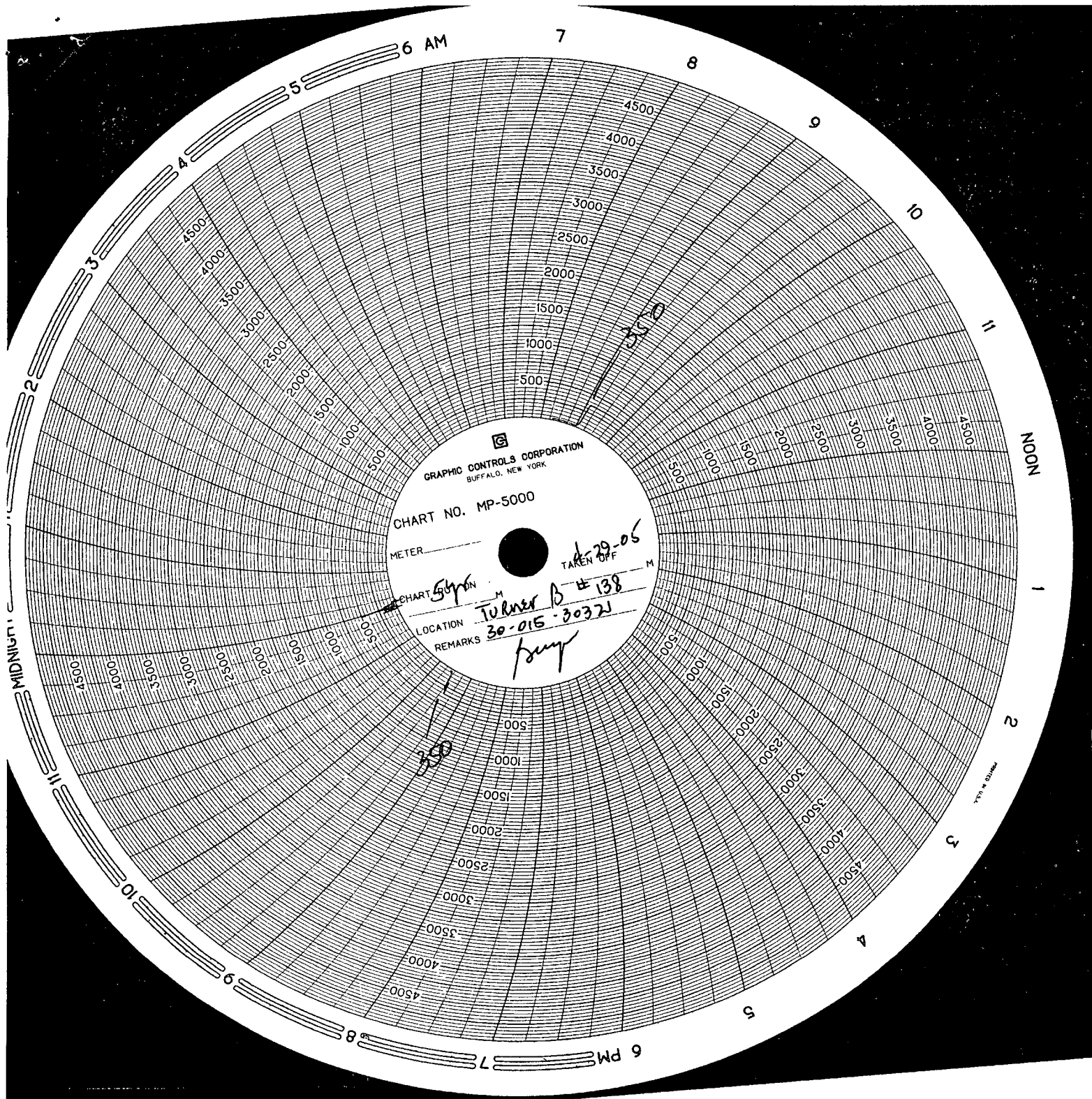

Conditions**

- 1. Notice of Intent received in Carlsbad Field Office on 10/23/2009, subsequent report received in Carlsbad Field Office on 10/29/2009. Work done prior to approval – Incident of Non-Compliance will be issued.**
- 2. Well has been idle since July 2008. The well has previously been injecting at a pressure exceeding the maximum set by NMOCD.**
- 3. Operator had requested TA status from NMOCD which expired 7/31/2009. BLM was not contacted regarding TA status.**
- 4. If not already in place, operator is to install a pressure gauge on the casing annulus. Pressure to be monitored and documented at least once a week. Data to be available whenever NMOCD or BLM requires readings.**
- 5. MIT required in 2010 per 5 year NMOCD requirement.**
- 6. NMOCD and BLM to be notified if well is temporarily abandoned more than 30 days.**
