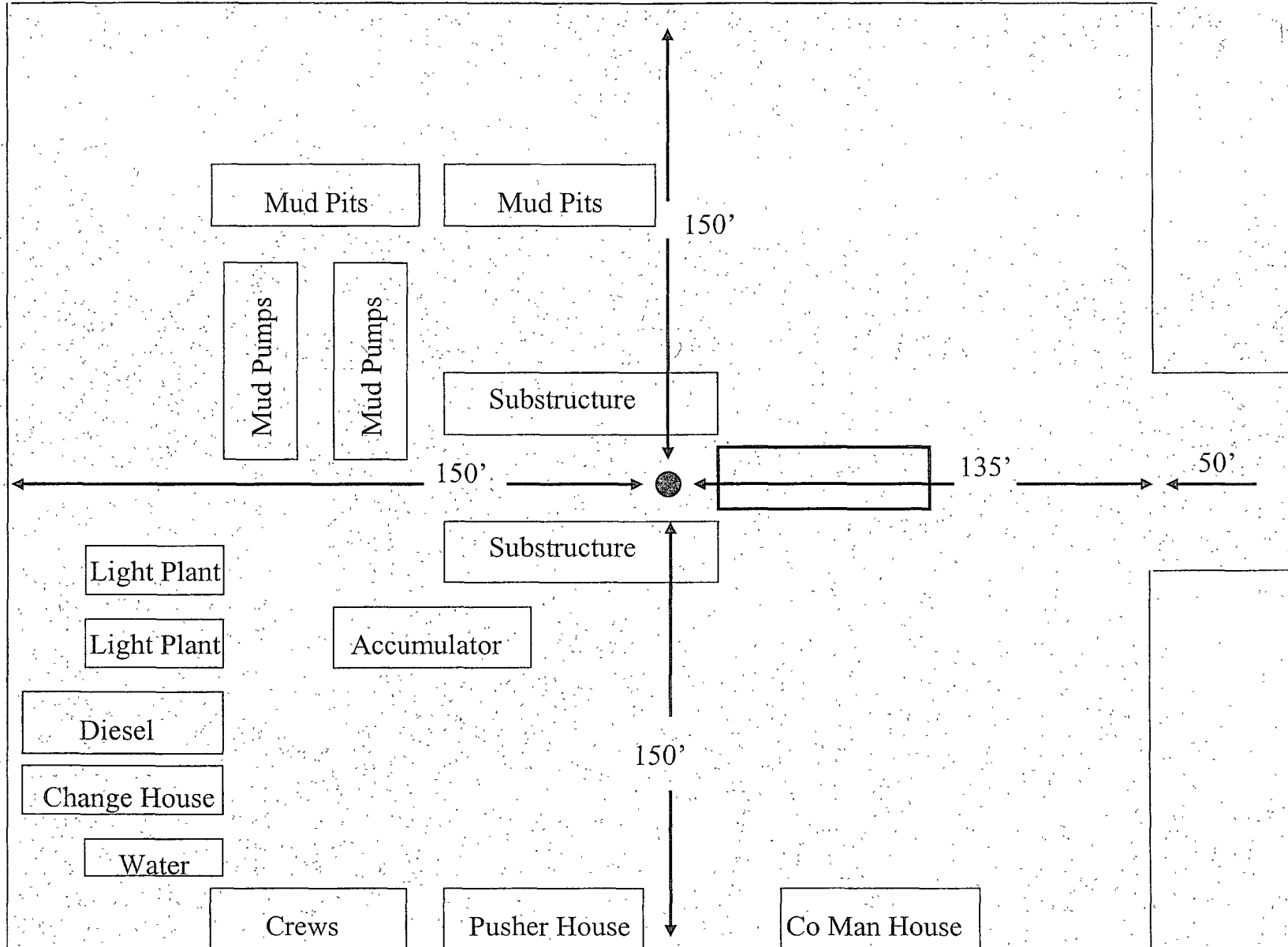

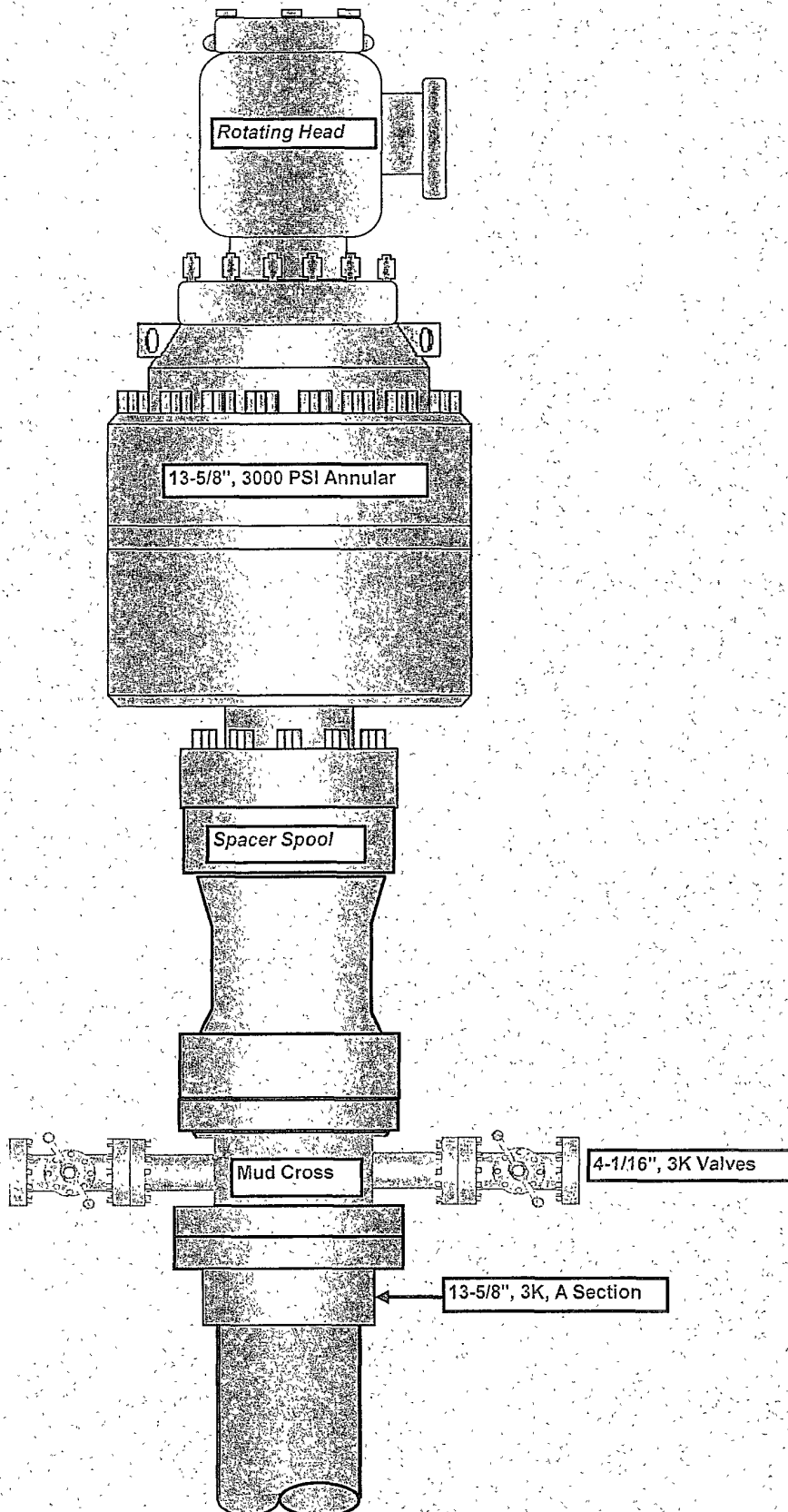

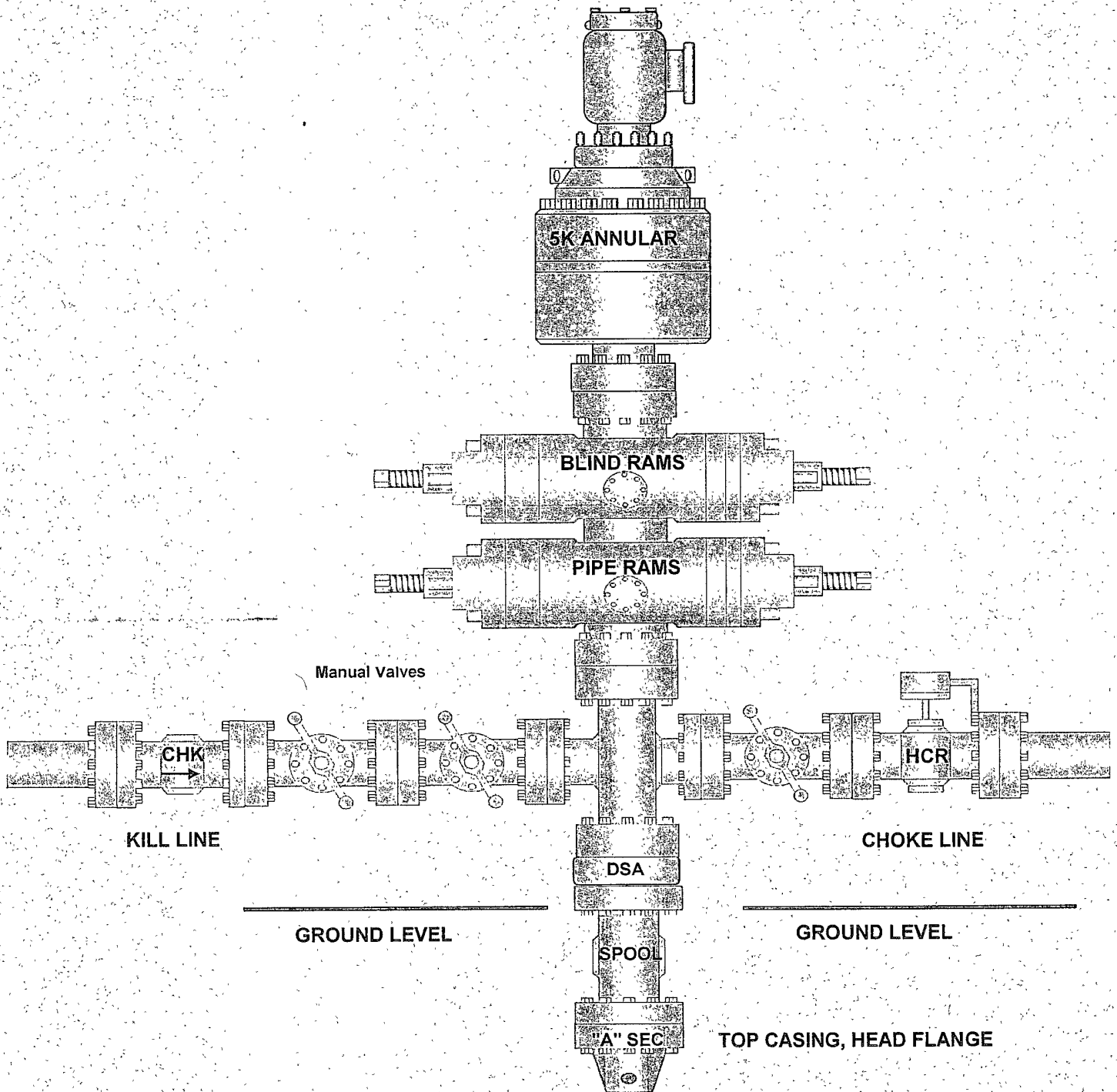
PATTERSON RIG 41
