01/07/2010: Hauled approximately 1944 cu ft caliche from location to BEU #54 road and main BEU road. (Samples taken from the west side of location showed chlorides were below 250 ppm max allowed by state of New Mexico.) 15,725 square feet was reclaimed from site and area was graded & contoured to blend with the surrounding topography. Cleared site will be re-seeded in the spring.

Site is ready for interim reclamation inspection.
