05/29/2009 PUH w/ EOT @ 10,600'. Spot 1000 gals 15% pickle acid down tbq, acid out EOT w/ 61 bbls 2% KCl. Displaced acid out of casing. Wood Group perf Bone Springs 7824'-7834' (30 holes). RD Wood Group.  
05/30/2009 RIH w/ pkr + SN to 7860'. RU Cudd & spotted 4 bbls 15% HCl. PUH to 7730'. Acidized perfs w/ 5,000 gals 15% HCl, used 46 1.3 SG balls evenly spaced to divert.
