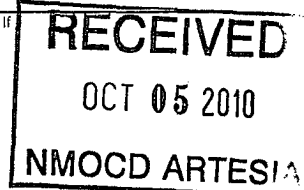

8/11/10 Reached TD 8-3/4" hole to 12,817'.

8/14/10 Set 5-1/2" 17# HCP-110 LT&C casing at 12,817'. DV tool at 5726' and 7845'. Float collar at 12,771'. Cemented stage 1 with 850 sx Halliburton cement + 30# Calcium carbonite + 0.5% Halad4-344 + 0.2% HR-601 (yld 1.87, wt 13.8). Cement circulated to surface. Opened DV tool and circulated. Cemented stage 2 with 605 sx Versacem + 0.4% CFR-3 + 0.5% Halad4-344 + 15% HR 800 + 3# Poly-E-Flake (yld 1.58, wt 13.3). Did not circulate cement on 2nd stage. Wait 40 min and circulated DV tool.

8/16/10 Rig released at 6:00 PM.
