4. Acidize w/ 500 gallons NeFe w/ additives.
5. Fracture treat w/ 15,000 gallons & 30,000 lbs 16/30 sand.
6. Recover load.
7. POOH w/ RBP, pkr & tbg.
8. Return well to production.
