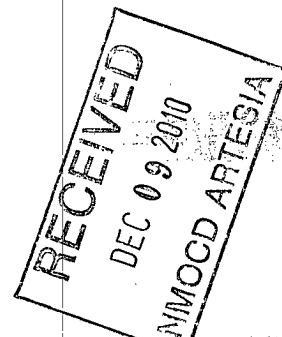
11/7/10 MIRU. Tubing pressure 500#. Set flow back tank. Install flowline, back flow well to tank.

11/8/10 Unseat packer, install BOP. Tally tubing out of hole, 124jts of IPC 2-3/8 tubing and packer. Test tubing to 3000# above slips. Install 4-1/2"x2-3/8" PC R-4 packer on 2-3/8 PC tubing, test tubing while GIH. Found two bad joints. Replace joints with 2jts of 2-3/8" PC. Leave packer swinging at 3997. SDON.

11/9/10 RU kill truck. Mix packer fluid. Pump 70bbbls packer fluid. Fluid circulated. Set packer. Install wellhead hook up. Pressure tubing casing annulus to 500#. Ran test chart for 35min. Tested ok. Darrell Gray with the NMOCD witnessed the test. NMOCD took test chart. RDMO.
