Tailed in with 200 sx Class "C" + 0.125#/sx D130 + 94#/sx D903 (yld 1.33, wt 14.8). Circulated 125 sx to pit. Tested casing to 1500 psi for 30 min. WOC. Reduced hole to 12-1/4" and resumed drilling.
