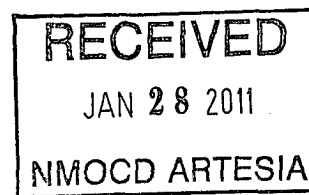

Perf Delaware A and B 4010-4018' (8 holes) and 4062-4072 (10 holes). Broke down perfs w/ spot acid. Treated perfs w/1800 gals of 15% NEFE HCL. Frac w/ 24,486 gals of 25# XL gel 53,000 of 20/40 SLC. Release RBP. Clean down to 4505'. RIH w/ 123 jts. 2-7/8" J55 tbg. Set TAC. RIH w/ production equipment and place well back on production.
