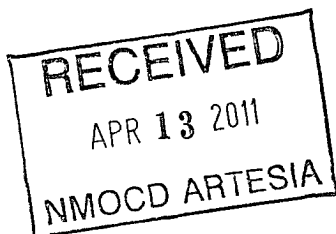

Cotton Draw Unit**

1. Centralizers required on horizontal leg, must be type for horizontal service.
2. The casing must be centralized adequately through the curve and in the vertical portion of the well to enable the cement to provide zonal isolation, from formations above and to enable production of the well at an orthodox location.
3. Subject to like approval by NMOCD.
