Cmted lead #1 w/175 sx (163 cf) "C" cmt w/10# Kalseal, 0.125# pe flake, 10# gilsonite, 1% Cacl2 & lead #2 w/175 sx (236 cf) "C" cmt w/2% Cacl2, & 1/4#/sx p-e-flake. Tailed w/200 sx (264 cf) "C" cmt w/2% Cacl2. Circ 161 sx cmt to surface. On 4/13/11, PT 8-5/8" csg to 600 psi for 30 min - OK.

Drilled 7-7/8" hole to TD3308' on 4/19/11. Ran open hole logs from 2215' due to bridge. Landed 5-1/2" 17# J-55 csg @ 3291'. Cmted lead w/400 sx (760 cf) 35/65 poz C cmt w/0.125#/sx p-e-flake, 3#/sx salt, 0.5% Halad-9, & 3#/sx gilsonite. Tailed w/400 sx (532 cf) "C" cmt w/0.125#/sx p-e-flake, 0.4% Lap-1, & 1/4#/sx D-air. Circ 156 sx cmt to pit. Released drilling rig on 4/20/11. Plan to pressure test the 5-1/2" csg before completion operations.

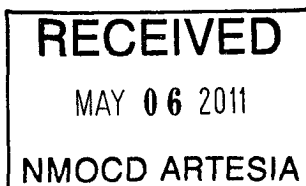
