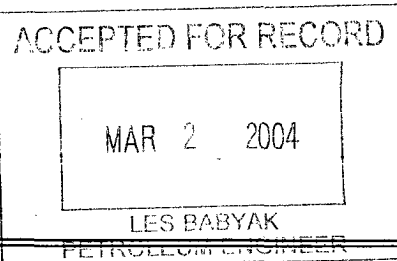

01/21/04 - Ran 64 jts 9-5/8" 40#/ft J55 STC casing w/10 centralizers. Set @2804'. Cemented w/1000 sx 35/65 Poz C w/1% CaCl, 1/4#/sk celloflakes & 5#/sk LCM1 + 200 sx "C" w/1% CaCl. Circulated 172 sx to pit.


