5. Cement 13 3/8" casing w/180 sks Hall.-Lite w/1/4# flocele and tailed in w/150 sks Hall Prem.-Plus w/2% CaCl. Plug down @ 1:30 PM. Circulated approximately 90 sacks cement to pits.
