WE PROPOSE TO DRILL THE ABOVE WELL AS FOLLOWS:

OBJECTIVE: Premier Sand (Basal Grayburg) Zone.
TOTAL DEPTH: Approximately 2900'.
METHOD OF DRILLING: Cable Tools to Total Depth.
CASING PROGRAM: Will Set Approximately 450' of 10 3/4" OD casing in top of salt and cement with 50 sacks. If sufficient water is encountered in the Queen formation will run approx. 2200' of 8 5/8" OD and obtain formation shut-off. In the event that commercial production is indicated a production string of 7" OD casing will be run and cemented at approx. 2850'.

DRILLING OPERATIONS TO COMMENCE: On or about February 20, 1958.

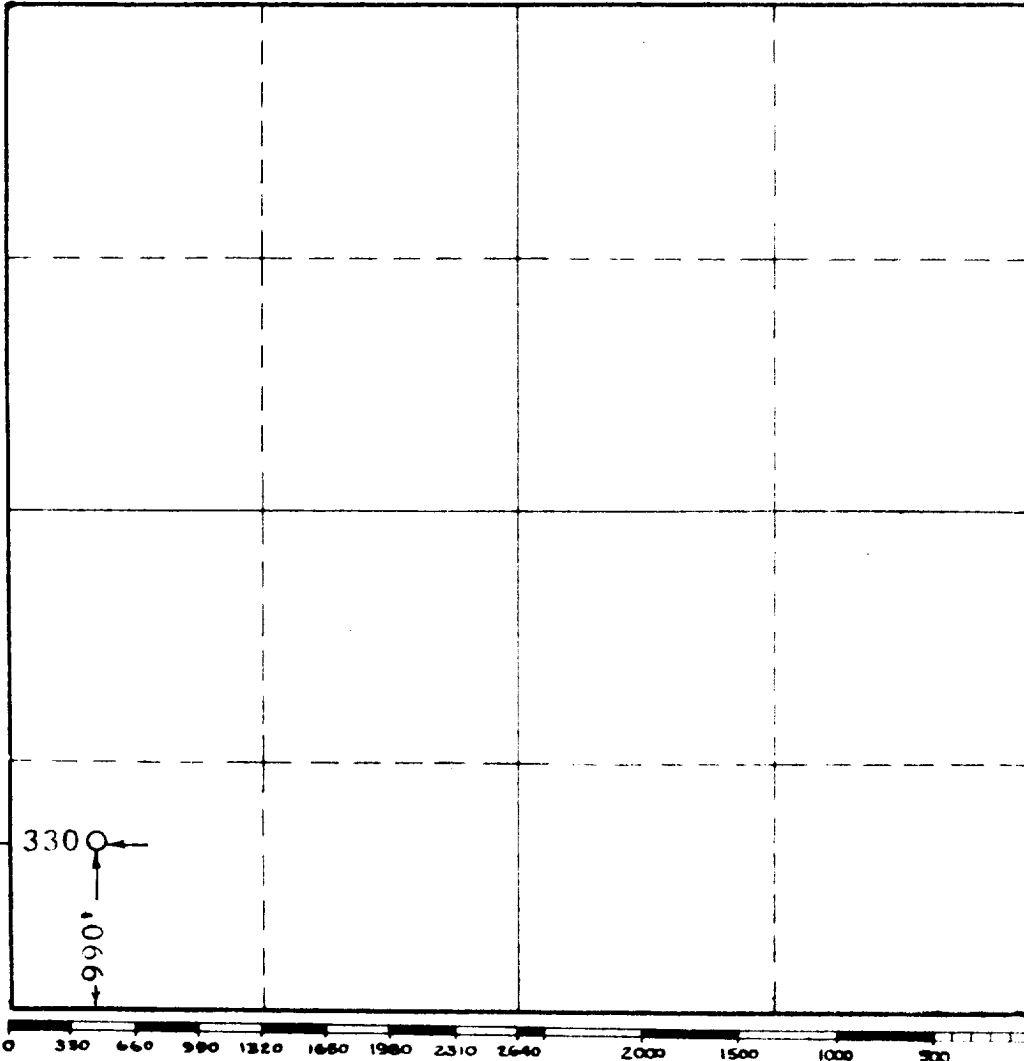
