This active water injection well failed the Bradenhead and Annulus pressure test conducted by the State of New Mexico Energy & Minerals Department, Oil Conversation Division on April 29 and 30, 1985, and General Operating Company proposes to repair as follows:

- (1) Pull tubing and packer.
- (2) Run cement bond log to determine top of cement behind 7" OD casing.
- (3) Locate hole in 7" OD casing with packer and bridge plug.
- (4) In event that cement top behind 7" OD casing is below base of salt at 1241', 7" OD casing will be perforated at cement top and cemented to base of salt.
- (5) Cement or repair hole in 7" OD casing.
- (6) Drill out cement from 7" OD casing and pressure test as required by OCD.
- (7) Run tubing and packer and place well back on water injection.

PERTINENT WELL DATA 7" OD casing at 3111' cemented with 100 sacks.
5 1/2" OD, 14# liner from 3082' - 3246' cemented top to bottom.
Liner perforated 3232' - 3240' with Abrasijet.
2 3/8" OD tubing set on packer in 5 1/2" liner at 3112'.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
