Workover existing water injection well as follows:

1. Clean out wellbore to TD.
2. Run 4 1/2" casing to TD and cement back to surface.
3. Selectively perforate the interval 2700' - 3575'(OA).
4. RIH with injection packer on 2 3/8"(IPC) tubing and set at ±2650'.
5. Return well to injection through perforations 2700' - 3575'(OA).
