3/9/98 – Acidized perfs 3469'-3683' with 1500 gals 15% HCl acid + 2000# rock salt.
Acidized perfs 2882'-3383' w/4052 gals 15% HCl acid + 8000# rock salt.
3/11/98 – RIH with injection string. Returned well to injecting.
