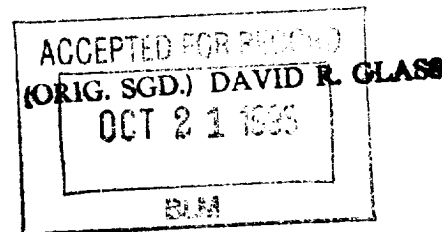

Acidized perfs 3799'-3916' w/2000 gals 15% HCl acid.
Ran in hole w/5 1/2" AD-1 pkr & 99 jts of 2 3/8" plastic coated tbg to 3110'.
Set pkr @ 3110' & tested.
