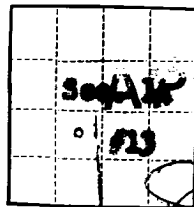

Propose to drill with Rotary Tools using gas from surface to total depth of approx. 3050' in the San Andres Formation. Casing program to be approx. as follows:

7-7/8"	4-1/2"	3050'	305

The pump & plug process will be used in cementing both strings of casing. The well will be perforated and treated with approx. 1500 bbls. of lse. oil and approx. 60,000' 20/40 sand.

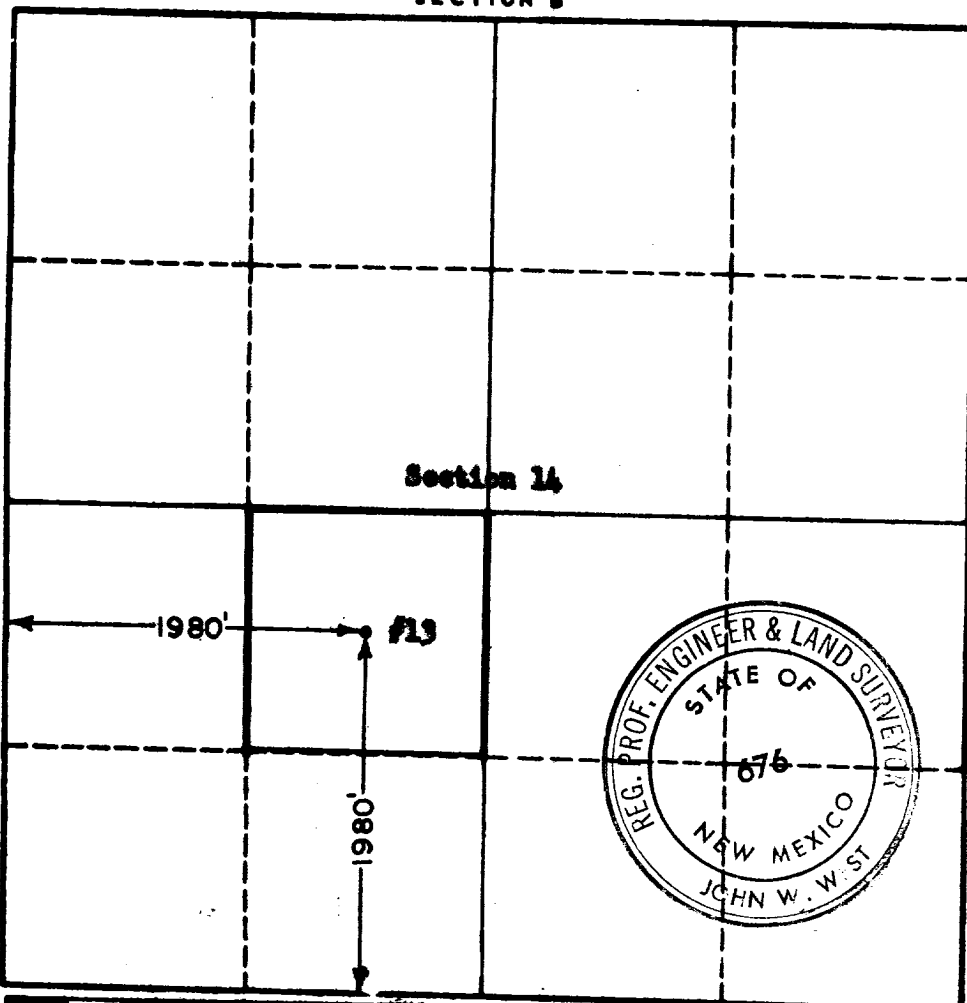
