Acidized perfs 2768'-3023' w/2500 gals 15% HCl acid + 2500# rock salt.

10/2/98 - Ran injection tubing & packer. Set packer @ 2703'. Returned to injection.

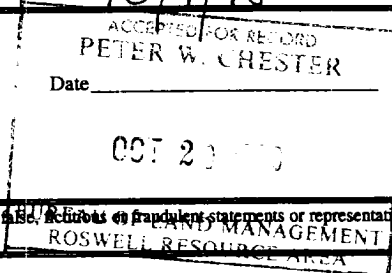
